I am very excited to be part of the United Church experience with the beautiful people I have met at Shelburne-Primrose. Upon arriving in September, besides meeting many people, I became acquainted with the pastoral charge and the area. The Spirit is at work within this charge, and I am thrilled to be on board for the ride.

These past four months have been hectic. Since arriving, I set out on a pastoral care journey, foundation building and opportunity analysis. My first concern is knowing who you are as individuals, congregations, and pastoral charge. I asked many questions received multiple fascinating and sometimes challenging answers. I prayed and pondered.

Through this process, and despite the limitations put upon us by COVID, I made several visits to individuals, received numerous emails and was on the phone until my ears burnt.

We have had regular worship services every Sunday in both parts of the charge. We celebrated communion once. I witnessed God at work when you come together to organize events, sing, prepare and serve food, rally individuals, and find pockets of energy, generosity, and collaboration. God is embodied in his people getting together without exclusion to share their gifts and reach out.

These first four months have been full of learning; it would not have been possible without your support and understanding.

We reviewed the first three months performance with Irene in her new position of CTC and recommended a pay increase in compliance with our contract, to the Shelburne-Primrose Pastoral Charge Council.

I want to thank our Musical Director Bruce our Communications and Ley, Technology Coordinator Irene Chinyenze, The Custodian of Trinity, Terry Ouellette, Gord Gallaugher, the Keeper of the Accounts and our Minister, Rev. Valerie Vande Wiele for the co-operation, service and support that you have provided during my time as Chair of the Ministry and Personnel Committee. First Line for Syria

First of all we bring you news of our first family, who arrived in February of 2016 and is now successfully integrated into Canadian society- in London, Ontario and have been approved for full Canadian citizenship! We are staying in touch with them and can report that Helin is an inspirational young woman who enjoys being a university student while Sabah and Khaleel are considered elders of the Kurdish and Syrian community there. They send many greetings to their many friends!

First Line for Syria had an exciting 2021, with the wonderful news this late summer that our sponsored refugee family would be landing within a few short weeks. This arrival had been "in the pipeline" for the past 4 years, with us constantly requesting urgent action. We were almost beginning to lose faith that this reunion with their family in Alliston would ever happen- but by late August we were jolted into action! We succeeded in collecting all clothing and furniture needed for the impending arrival; we secured a house in Alliston and finally could show that we had secured enough money to be officially approved for our family's arrival. All of this was made possible by the generosity of our local community and our many other donors and finally thanks to the overwhelming support from the members of the congregations of Trinity and Primrose.

After an extremely stressful day of travelling, on October 21st, 2021, our family finally arrived in Canada and could (after a 2-week quarantine) be fully reunited with their extended family in Alliston. Many tears of relief and happiness were shed, and we were overjoyed to have been able to facilitate such a long-awaited reunion! First Line for Syria is blessed to have the eager support of our family's relatives in Alliston. Our job has been made much easier by the fact that they are always there, ready to help.

We are happy to report that all the children are in school, and they are adjusting just fine. They have not had any form of schooling for the past eight years, so it is a steep learning curve, but thankfully they have their 7 cousins in Alliston, who are helping them learn English and guide them as they navigate school life. The parents are incredibly self-sufficient and these days getting ready for their G1 exam. They are learning more English, even though during Covid there are no formalized ESL inclass programs.

When we know what this family has gone through over the past 9 years (since their home in Syria was demolished by bombs) it never ceases to amaze us how resilient they are. This a family of immense personal strength and impressive optimism! They clearly do not wish to dwell on a horrific past, but rather they are ready to move forward.

It has been such a privilege and an inspiration for us getting to know them. We are convinced that they will be an asset to their local community - and to Canada as whole.

However, our work is not done: The videos of our family saying goodbye to their close relatives, who our family have shared their lives with, in the refugee camp, were heartbreaking. Our hope is therefore to bring to Canada the remaining family members, as 2 brothers /2 sisters-in-law and their combined 9 children are still stuck there, in appalling conditions in a bleak refugee camp in Jordan. We strongly feel it is the only right thing to do; to work towards bringing these close relatives here to further family reunification. In December we received the unanimous support from Shelburne Primrose Pastoral Charge Council to continue working towards this goal. By December 22nd we also received notification from United Church Central that they had now received our applications for these 2 families, in time to be considered for 2022.

Part of submitting these applications has been the task of interviewing each adult. They have told us their stories (via cell phone and translation) about what has happened over the past 9 years. We have established why they had to flee Syria, how they made it to the refugee camp, and why they cannot ever return to their home country and how hopeless their situation currently is, sitting in a crowded refugee camp in Jordan.

It is the story of a young woman running frantically in the street in Damascus, clutching her newborn child, after her home had been levelled to the ground by bombs. It is the story of a brother being tortured- and another brother being brutally murdered- and a whole family being targeted. It is the story of their father being killed in a bombing raid. It is the story of slowly walking in the dark of night towards the Jordanian border, carrying young children and hiding from sniper-fire during the daylight hours. It is the story of being separated from, but never giving up searching for your wife and young children - before finally finding them, after 7 months in a crowded border camp.

It is the story of young hard-working families who thought they would be refugees for a few months, but now it has been 9 long years since they lost everything. It is the story of a being in a refugee camp where children never have access to formal schooling and adults are not allowed to work. It feels like being in a prison-situated out in the desert where kids never see grass or any trees. It is the story of living in a place where there is one ambulance that will come only once daily- to collect the women who are in labour and where the children learn to fear that when an ambulance arrives it might mean that yet another mother will die, because help has come far too late. It is also the story of saying a heart-wrenching goodbye to your brother and sister-in-law and their kids as they leave you behind and are finally able to travel to safety and a new life in Canada.

And so our work continues: First Line for Syria wishes to thank SPPC and the congregations of Primrose and Trinity for their steadfast support over the past 6 plus year. It has been a truly rewarding experience working together with you, in bringing these amazing refugee families to safety in Canada!

Partera Peacemakers International

The Memorandum of understanding between Partera Peacemaker International and Shelburne Primrose Pastoral Church has been terminated as requested by Partera effective December 31, 2021.

Shepherd's Cupboard Foodbank

The foodbank has experienced unprecedented numbers of clients this year. When compared with March 2020, we are serving 74% more clients each month. Food, housing, health and job insecurities have all surfaced during this pandemic and we continue to stretch to try and meet the need for food and toiletries.

We continue with the drive in method of serving clients, delivering food directly to clients' cars. Supply chain difficulties find us scrambling at times to purchase items needed for the hampers. The county was no longer able to deliver to those who couldn't access the food bank for health reasons so we now have some volunteers who once a month deliver to seniors in need. As well the foodbank partnered with Rotary to host a free Seniors Market the fourth Thursday of every month at the 4 county buildings in Shelburne, bringing fresh produce, eggs, milk and assorted groceries to their parking lots. This continued until November and we are looking at hopefully starting this again in March.

The foodbank again joined with the Christmas Hamper program to ensure all those who needed it were registered and received a hamper for Christmas. It is busy at the foodbank but we work harmoniously to serve.

We were very grateful that Rev. Valerie has joined our board of directors at the foodbank as she has a true interest in those that are in need. We were saddened in December at the passing of our treasurer, Pam Church. Anthony Gagliardi, bank manager at TD stepped into the role.

We are thankful to Primrose for their contribution from their Christmas Craft sale and all the congregants who make donations that enable us to serve the community of Shelburne and surrounding areas. 100% of donations go directly to food and hygiene items for the clients.

Thank you to those who volunteer to help sort food or make hampers or work shifts at the foodbank - we couldn't do it without you!! Please continue to keep us in your prayers as we provide emergency food support to our neighbours, friends and members of our community.

Moved by Karin seconded by Sabine to approve the committee reports submitted pages 1 to 11 and pages 12 to 16. Carried

Moved by Dianne seconded by LeeAnn to accept the Annual Report. Financial Report and Budget page 40 after the following changes —-Donations to Memorial should be zero amount. M & S budget should be \$500. The capital budget is to be added to the Budget Report. Money is to come from our investment maturing in February to cover the building repairs in the spring but we need to see the figures and for approval. Then if monies still left in the investment we will then decide what is needed to be done with the funds at our April council meeting. Carried

The Pastoral Charge annual report was approved at Pastoral Charge. Bruce Ley is to be paid from Pastoral Charge going forward. Percentage of expenses is Primrose 22.8% Trinity 77.2%. The Manse Investment is controlled by United Church of Canada. Distribution is 1st portion on report is Trinity; second portion Primrose. The Bell shares are distributed the same. Moved by LeeAnn seconded by Jeff to appoint Bruce and Dianne Irwin to be the auditors for 2021. Carried

For now we will be doing a revolving secretary. **New Business**: Sabine and Jill gave a detailed Quartet Report and Worship Services. They would like to have a zoom meeting with congregations to guide people through the web site which seems to be difficult for some and thet would like feedback on what congregations would like to see going forth.

Karin gave a Search Committee update. It has been very difficult through COVID-19 to do the search and is becoming very frustrating to the committee. They had asked The United Church of Canada to have approval to hire LeeAnn McKenna as a supply minister but did not get approval. Her services can be used on podcasts

Property Rentals: Committee of Ken McGhee, Bob Thomas and Jeff Cottam was set up to do research into the request from Primrose Christian Centre wanting to hold services at our church. Each gentleman gave their report and we then had a very lengthy discussion. The following motion was then brought forth for a vote of those in attendance.

For the use of our building and that a rental agreement be drafted and brought to the Primrose United Church congregation for approval prior to presentation to Primrose Christian Centre. When the agreement is prepared it will be voted on at a congregational meeting.

A committee of Jeff Cottam, Bob Thomas and Wally Barr will prepare this agreement. Ken McGhee has declined from going forth on this committee. Thank you Ken for the research you have done on this matter.

Gail and Gwynn gave a fundraiser report. We will have an online plant sale Mother's Day weekend and hopefully on line bake sale (depends on COVID-19 regulations for baking). On line perennial sale in June and suggestions have been made on other events. Stay tuned!

Our Historical Role needs updated and Dianne has volunteered to work on this with help. Our next meeting will be **Monday, April 12 @ 7 p.m.**

PROPERTY REPORT

The year 2021 found the pews empty and the doors closed for many months due to the COVID 19 pandemic. During these months there were many repairs and upgrades done on the 146 year old little white church. Some of these projects were brought about after the air quality testing we had done the year prior. Here is a list of repairs and improvements that were carried out-

Exterior -

1- The crawlspace under the rear addition was cleared of all sorts of items including construction rubble and racoon droppings. A load of rubbish was hauled off to the county transfer station.

2- The interior of the crawlspace, including the four walls and the underside of the floor, were sprayed with 2" of foam insulation.

3- The shingles on the rear addition were stripped off and new shingles put down.

4- The rain gutters and downspouts around the whole of the building were replaced.

5- The two exterior doors and trim were repainted.

6- The rear door concreate step was centered with the door and then leveled properly.

Interior –

1- A work crew was called together to clear the three rear addition rooms and remove the baseboards in preparation for the installation of new flooring.

2- Two of these three rooms received a fresh coat of white paint.

3- The old carpeting in the rear addition was removed and new vinyl plank flooring installed.

4- The old baseboard was stained and re-installed.

The crawlspace work along with the new flooring and painting has greatly improved on the musty, stale smell that has persisted for many years. I want to thank all the Primrose folks that pitched in and helped out when needed during this year, and to those that played a big part in cleaning and disinfecting the church once the doors were finally opened from September till the end of the year.
